Marsh is dropping some of the larger programs for issues they are having. Elaine is trying to get a justification of how they decide to accept programs. Marsh has agreed to provide a full report, probably this week. Elaine has requested the report right away.
- The second company Legacy has policy with same coverage plus property the cost of the policy is \$500. The coverage is through Great American Insurance
- Russ, Legacy insurance has recommended that we have D & O insurance. It
 covers insurance liability. The cost is \$768 dollars for CSUSA. We need liability
 and d & 0 because they cover separate issues.
- Legacy Insurance has been invited to the Florida State Conference in Tampa Florida at the end of the month.
- Legacy has asked to put out CSUSA information at the Florida meeting as well.
- Scott has a Fiduciary Bond that covers the treasurer. Scott has requested an
 detailed report on what the D&O insurance covers.

Operation Infra:
