







Gun Bounty Program: On June 29 a press conference was conducted at KCPD police headquarters in regard to the introduction of our "Gun Bounty" program. If the specified requirements are met we will pay the TIPSTER \$1,000.00 for their anonymous information out of our special account of which \$25,000 was donated by the City of Kansas City, Missouri.
