With the increased number of school shootings this year, Crime Stoppers is needed more than ever. After spending some time in Washington DC I have seen the effect these school shootings have had on our legislators and government employees. Over the past several months CSUSA representatives have had meetings in Washington DC with Homeland Security, the National Fusion Center Association, the Blue Campaign, the Polaris Project and multiple Senators and Representatives increasing their knowledge of how Crime Stoppers USA programs operate and how we can assist

them. Discussions covered school shootings, terrorism, SARS, human trafficking and funding for Crime Stoppers programs across the United States and Territories.

Our last series of meetings may be starting to bear some fruit. In a nutshell, we are asking for a bill to be passed in the US House of Representatives which would reimburse Crime Stoppers USA programs for all the rewards they pay out in a year. The money would come from forfeiture funds controlled by the Treasury Department. We have been receiving assistance from Richard Menzi, a Washington DC attorney, who is now our Legislative person in Washington DC. We have also received assistance from Jay Grant who is the Secretary General of the InterPort Police – International Association of Airport and Seaport Police. Jay was a lobbyist in Washington DC for twenty years and is a huge help. Please keep an eye on your email and make sure your email addresses are up-to-date in the CSUSA database. We may be asking you to contact your Congressional Representative or your Senator.

We have also had successful meetings with the Department of Homeland Security. In the future they will be working with Crime Stoppers USA to provide training for our call takers at the call centers and some of the training will be similar to what the 911 operators receive concerning how to recognize SARS events. Also, we will be working with the Blue Campaign on human trafficking. More information will be shared with you in the near future.

The CSUSA 2014 Conference in Austin is just around the corner and if you have not registered please do so quickly as the hotel is starting to fill up. The Conference Committee has planned excellent training c courses which will be relevant and pertain to what you do. Networking with others from around the country and learning about what they do to keep their program current is also a big reason to attend.

Thank you for being a part of the best crime fighting organization in the world. You are all making a difference!

## **Border security: Violence and corruption by drug cartels hits homeland**

While the American media devotes much time and effort to pinpointing the violence and corruption generated by the drug cartels in Mexico, far less attention is devoted to crimes in this country which are a direct result of these same criminal organizations. The corruption of American law enforcement has become a significant problem along the border. The Mexican drug cartels which control drugs and human smuggling are directly responsible for a spiraling level of violence and crime which instills fear among residents on both sides of the border even as it lowers the quality of life for all who call the U.S.-Mexican borderlands their home.

While the American media devotes much time and effort to pinpointing the violence and corruption generated by the drug cartels in Mexico, far less attention is devoted to crimes in this country which are a direct result of these same criminal organizations. A case in point is the Panama Unit in south Texas.

A street-level task force created by Hidalgo County Sheriff Lupe Trevino in 2009, one unit leader was the son of the police chief of the city of Hidalgo along with Mission police detective Johnathon Trevino, Sheriff Lupe Trevino's own son. Also included were members of the Mission police department who, along with other members of the Hidalgo County Sheriff's Crime Stoppers unit, began guarding drug loads for known traffickers. Another member of the Panama Unit was Mission police department's Alexis Espinoza, the son of Chief Rudy Espinoza who is head of the Hidalgo police department.

For more than three years the Panama Unit provided protection for drug traffickers and, at the same time, stole drugs from these same smugglers as they made a mockery of law enforcement along the Mexican border (Ildefonso Ortiz, "Feds Arrest Hidalgo County Sheriff's Commander," *The Monitor*, 24 December 2013)).

Witnesses said that the son of the Hidalgo County Sheriff and the son of the Hidalgo's police chief both believed they were invulnerable to arrest for their crimes because of their fathers' status in local law enforcement.

Charges were finally brought against the Panama Unit when Miguel Flores, in the Hidalgo County Sheriff's Department wore a wire for the FBI (Melissa del Bosque, "Exclusive: The Man Behind Hidalgo County's Biggest Law Enforcement Scandal," *Texas Observer*, 28 May 2013).

Recently demoted from his position in law enforcement, Flores believes that Sheriff Lupe Trevino is punishing him for providing information which led to the arrest of the Sheriff's son. Officer Flores has filed a whistleblower's lawsuit against Sheriff Lupe Trevino.

Also arrested, after nine former members of the Panama Unit pleaded guilty, was Jose Padilla. Padilla is the former Commander of the Hidalgo County Sheriff's office, Sheriff Trevino's second in command. He is accused of protecting drug traffickers from rival gangs as they smuggled and distributed illegal drugs throughout Hidalgo County. Commander Padilla is <a href="described">described</a> as, "...a ruthless enforcer who forced (Sheriff) deputies to bring cash to him for political purposes..." in a county which is one of the poorest in the country.

While Hidalgo County Sheriff Lupe Trevino staunchly maintains his innocence and has stated he was not aware of the illegal activities of his Panama Unit, corruption in the Hidalgo County Sheriff's Office runs very deep. Former Hidalgo Sheriff Brig Marmolejo served time in prison for his participation in drug-related crimes. Former Sheriff Conrado Cantu, who was the head of law enforcement in adjacent Cameron County, was sentenced to twenty-four years in prison without parole for accepting bribes from drug traffickers, laundering drug money, and related crimes which included accepting \$10,000 to protect a drug smuggler. The presiding judge in Sheriff Cantu's trial characterized the defendant's crimes as, "...egregious activity that only served to promote the illegal narcotics trade." (Robert Lee Maril, *The Fence*, pages 54-55; and Sergio Chapa, "Cantu Sentenced to 24 Years," 14 December 2006, *McAllen Monitor*, p. 1.)

Another alarming example of increased violence among border law enforcement is the recent kidnapping and sexual assault of three females who illegally crossed the Rio Grande near Mission in March, 2014. A Customs and Border Protection agent, Esteban Manzanares, has been identified by the victims and by film surveillance in the case now being investigated by the FBI. Agent Manzanares, who committed suicide before he was about to be arrested in his apartment where he took one of his victims, is accused of detaining these three women, including two teenagers, as they sought to surrender to authorities. Agent Manzanares stands accused of taking these women to an isolated area where he slit the wrists of the mother of one of the victims, assaulted one of the teenagers, then took the remaining teenager to his apartment in nearby Mission. (Juan Carlos Llorca, *FBI: Dead Border Agent Suspected in Kidnapping*, <u>Associated Press</u>, 13 March 2014).

Several days after the assaults and kidnapping, Commissioner Gil Kerlikowske, head of U.S. Customs and Border Protection, apologized for Manzanares' crime saying, "I am deeply sorry that this incident occurred and am committed to doing everything in my power to prevent incidents like this from occurring again." ((Ildefonso Ortiz, "After Immigrants attacked, CBP chief apologizes, Reps. Cuellar and Castro chime in, civil rights attorney slams Border Patrol, *The Monitor*, 14 March 2014).

CBP Agent Manzanares joined the Border Patrol in 2008 during a time when Congress mandated a rapid increase of agents from a modest number of about 4,000 to the present 23,000. The professional training for all new agents at the Border Patrol academy was reduced from six months to just fifty-three days allowing little time to develop the professional law enforcement

skills of all CBP agents who received less than two months of classroom and field experience in immigration law, Spanish, and weapons training.

The Panama Unit and the crimes against three Honduran females by a CBP agent in south Texas are symptomatic of border violence and corruption with direct ties to illegal drugs and human trafficking. The corruption of American law enforcement has become a significant problem along the border. The Mexican drug cartels which control drugs and human smuggling are directly responsible for a spiraling level of violence and crime which instills fear among residents on both sides of the border even as it lowers the quality of life for all who call the U.S.-Mexican borderlands their home.

## SIDEBAR with the Judge

## **Protecting Crime Stoppers Tipsters**

Sometimes the umpire needs a little help in making the Call. Judges hear a variety of cases in their respective courtrooms, and they don't always have the best view or perspective. Especially when deciding a case involving new issues. Not that umpires are blind...although justice is supposed to be<sup>©</sup>

It is inappropriate for parties or their attorneys to make "ex parte", or one-sided, unilateral communications to a judge. Such is unethical and perhaps even unlawful.

However, through oral argument and pleadings in adversarial proceedings where both sides have the concurrent attention of and access to the judge, information can be lawfully communicated to the judge.

It has become apparent that an increasing number of judges have been conducting *in camera* hearings to determine what information contained in Crime Stoppers tips should or should not be disclosed to a criminal defendant using the redaction process.

It is my belief that if a judge is provided with an example of a proper Order delineating what is to be redacted from a Crime Stoppers tip and the legal reason(s) for redaction, the judge is more likely to use it as a template that can be adapted to their case at hand.

That was exactly the situation in a case decided in late June of 2014. The judge used the Order from the *Atwater* case in North Carolina. Information was

released to the criminal defendant and attorney, but in a manner which did not endanger the Crime Stoppers tipster.

So where can the *Atwater* Order be found? Wherever you had it last. The decision has been on the last two versions of the Crime Stoppers Super CD distributed at no charge by Crime Stoppers USA each year to dues-paid members of CSUSA. It can be found under the "Case Law" folder. Do yourself, the tipster, and your Crime Stoppers program a favor by sharing the decision and its format with your criminal prosecutor and criminal court judges now.....BEFORE the next case is before the court and "ex parte" communications become a factor.

### **Quick Shots**

I was recently asked whether a Crime Stoppers organization should accept a \$1,000 charitable donation from a gun manufacturing company that had recently relocated to area and wanted to help out the community. My answer was that if the gun manufacturer sells firearms to law enforcement and to the military, the fact that the same brand of firearm is occasionally used to commit crimes is not enough to dissuade me from recommending that Crime Stoppers accept the donation.

I was also asked whether Crime Stoppers text tips received via text messages should be received and handled by members of the Crime Stoppers board of directors who are not law enforcement officers. It has always been my preference that tips be received and processed by law enforcement officers who are knowledgeable of elements of criminal offenses and thoroughly familiar with probable cause. However, that luxury is not always possible. If board members are going to assume this responsibility, I suggest that first receive proper training on the legal duties, operational procedures, and potential consequences of errors. I typically recommend sixteen (16) hours of instruction as the minimum threshold.

In the last issue of *The Informer*, the \$Financial\$ Corner discussed some of the various reporting requirements of exempt organizations with respect to the annual informational return, more commonly referred to as Form 990, Form 990-EZ or Form 990-N. However, another question that comes up quite frequently is whether Crime Stoppers are required to file Form 1099-MISC for rewards paid to anonymous tipsters.

Generally, miscellaneous income payments of at least \$600 in rents, services, prizes, awards paid to individuals and businesses must be reported by the issuing organization on a Form 1099-MISC. Of course, as with any Internal Revenue Service (IRS) regulation, there are numerous exceptions to the rule! In the past, some Crime Stoppers organizations believed they were exempt up to \$1000 based on a Private Letter Ruling (PLR) by the IRS, a procedure by the IRS providing interpretation, guidance and determination on specific tax issues. However, PLR's may not be relied upon as precedent by other taxpayers. In addition, in searching the PLR's by the IRS, nothing could be located regarding the waiving of Form 1099-MISC up to \$1000 for Crime Stoppers organizations.

However, the good news is that the IRS made some modifications to Form 1099-MISC regulations in conjunction with the Patriot Act in the mid-2000's. Therefore, specific instructions in the Form 1099-MISC now include this instruction:

**Exceptions:** Fees paid to informers. A payment to an informer as an award, fee, or reward for information about criminal activity does not have to be reported if the payment is made by a federal, state, or local government agency, or by a nonprofit organization exempt from tax under section 501(c)(3) that makes the payment to further the charitable purpose of lessening the burdens of government.

With this information, Crime Stoppers programs are not required to file Form 1099-MISC for reward payments made to anonymous tipsters since the organizations are usually nonprofit organizations exempt from tax under 501(c)(3). Why is this important? If a Form 1099-MISC had to be prepared for these reward payments, the Crime Stoppers organization would have to acquire the individual's name, address, Social Security number, etc. As you can see, this would no longer guarantee the anonymity of the tipster, so this is vital to Crime Stoppers organizations.

A note of caution, however. There has been much discussion about large rewards being offered by Crime Stoppers organizations for high profile or significant cases within their communities. Rewards of \$10,000 or larger had been offered in an attempt to highlight a particular crime in the hopes of solving it. Although the IRS no longer requires the Crime Stoppers organization to complete a Form 1099-MISC, the Patriot Act has had an impact on the banking industry as well. Any cash payment of \$10,000 or above will require an individual to provide their name, address and Social Security number, so it is important to keep this in mind with respect to tipsters and anonymity.

Finally, although Crime Stoppers organizations no longer have to report reward payments on Form 1099-MISC, the anonymous tipster receiving a reward payment may still be required to provide this reward payment as reportable income on their personal income tax return, as the IRS regulations indicate rewards and awards are taxable income.

Should your Crime Stoppers organization make other types of payments to independent contractors, for legal services, etc., you are still required to file Form 1099-MISC for these types of payments on an annual basis. Remember, keep your Crime Stoppers organization out of the newspaper by remaining compliant with any and all Internal Revenue Service requirements!
