

REWARD AGREEMENT

This Agreement entered into this 3rd day of September, 2012, between Mr. Del Hedgepath, 303 Emmanuel Cleaver III Drive, Kansas City, Missouri, 64112, 816-898-7770, dhedgepath@nv-kc.com, (hereinafter, the "Contributor"), and the Kansas City Metropolitan Crime Commission, a Missouri nonprofit corporation (hereinafter, the "Commission").

In consideration of the following mutual covenants and agreements the parties agree:

1. The purpose of this Agreement is to offer and pay a reward up to \$6,000 (\$1,000 from Crime Stoppers TIPS Hotline Program and \$5,000 from the Contributor) for information leading to the earliest possible identification and arrest of the person(s) responsible for the homicide of Timothy Riley that occurred on September 26, 2012 in the street at 4128 South Benton in Kansas City, Mo.
2. Contributors have deposited, or promptly after the effective date of this Agreement, shall deposit the Reward with the Commission to be held for payment and distribution by the Commission as hereinafter provided.
3. The Commission shall administer and publicize the Reward and shall deposit the Reward in a special reward account maintained at a financial institution in the greater Kansas City, Missouri area. The Commission shall

make payment or distribution of the reward, or any part thereof, only under the terms and conditions hereinafter set out:

- a. All persons who are entitled to receive awards are included in the offer of the Reward.
 - b. Payment of the Reward, or any part thereof, shall be made only to such person or persons who, in the sole and exclusive judgment of the Commission furnishes information leading to the identification and arrest of the person or persons responsible for the crime.
 - c. Such information must be reported to the Kansas City Metropolitan Crime Commission, 3100 Broadway, Suite 226, Kansas City, MO 64111, telephone (816) 960-6800, or the Crime Stoppers ***TIPS HOTLINE***, telephone 816-474-8477, about the aforementioned crime prior to midnight, D.S.T., March 3, 2013, (6 months from the date of this Agreement), at which time the offer of the Reward shall automatically terminate, unless this time is extended by written agreement between the parties hereto.
 - d. Upon termination of the offer of Reward, the offer of Reward shall be null and void and of no further force and effect.
4. The Board of Directors of the Commission shall have the sole and exclusive authority to determine all matters concerning the administration,

publication, payment and distribution of the Reward, including without limitation:

- a. Any dispute as to eligibility to receive the Reward, or any part thereof;
- b. Any other matter connected with the payment or distribution of the Reward or compliance with the terms and conditions of the offer of Reward, and
- c. In the event that two or more persons provide information which falls within the offer of Reward, a just and fair division of the payment of the Reward, the total of which division shall not exceed the total amount of the Reward.

The decision of the Board of Directors of the Commission in all such matters shall be binding and final on all parties interested, including all parties hereto, and all contributors, claimants, or persons furnishing such information.

5. The Commission shall use its best efforts to determine that leads and information received as a result of the offer of Reward are fully developed by the appropriate law enforcement agency with the purpose of arresting the person or persons responsible for the crime.


6. In the event the offer of Reward terminates as herein provided or for any reasons does not become due and payable, the Reward, \$5,000 will be promptly returned to the Contributor.
7. All costs of administering the Reward, including without limitation, the cost of publication, shall be borne by the Contributors up to and including \$50, if requested. The Contributors shall pay such costs promptly upon demand therefore by the Commission only if needed and requested.
8. It is understood and agreed that the Commission may place the Reward in an interest bearing account until the Reward becomes payable or until the offer of Reward is terminated and the amount of Reward returned to the Contributors. All interest earned on the Reward shall be retained by the Commission to defray its expenses in administering the Reward.
9. In the event the reward money is not picked up within 1 year of the date the Board approves the reward, the Commission agrees to notify the Contributor and offer them the option of a refund or agreeing that the commission may have an unrestricted right to use the funds for other cases. A condition to a reward is that it must be actually picked up by the recipient within one (1) year of the Board approval of the reward. The Reward remains the property of the Commission until such time as the intended recipient takes actual possession of the funds within the time required.

10. The Contributors hereby release the Commission, its directors, members, employees, and any other person, firm, corporation or entity acting on its behalf, from all claims, actions, demands, liabilities or obligations of any kind, whether known or unknown, arising out of or which may hereafter arise out of, or in any manner be connected with, the administration, publication or distribution of the Reward.

11. This Agreement shall be governed by and construed and interpreted in accordance with the laws in the State of Missouri.

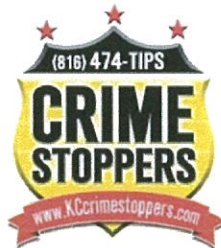

SUBJECT: Reward Increase in Timothy Riley Homicide

KANSAS CITY, MO --- The Greater Kansas City Crime Stoppers TIPS Hotline and the Kansas City, Missouri Police Department are asking for the public's assistance in identifying the person(s) responsible for the death of Timothy Riley on September 26, 2012 near 41st Street and South Benton in Kansas City, Missouri.

Officers were dispatched on a shooting call at 4128 South Benton at 12:56PM and Mr. Riley was found lying in the street suffering from an apparent gunshot wound. He was transported to the hospital but died several hours later. Witnesses report seeing an unknown black male suspect walk down the street, produce a gun and demand money from Mr. Riley. Mr. Riley attempted to leave the scene but the suspect gave chase and caught up to Mr. Riley and a struggle ensued. It was then reported that the suspect struck Mr. Riley with the gun and then shot him. The suspect then fled the scene on foot.

An anonymous donor has added \$5,000.00 to the reward fund in the case bringing the reward up to a possible \$6,000.00 for information leading to an arrest in the case. Ms. Joyce Riley, grandmother of the victim, is available for comment at 816-861-7568.

DISPOSITION NOTES

12/11/2012 - On 10-27-2012, Crime Stoppers received Tip Report #212J243 regarding the murder of Timothy Riley. Riley was shot and killed on 09-26-2012 in the 4100 Block of South Benton Ave. The above mentioned tip identified Landrain Miller as the suspect. As a direct result of the tip, we developed Landrain Miller, BM, 12-31-1994 as a suspect in the offense. On 12-06-2012, we arrested Miller for the murder. On 12-07-2012, the Jackson County Prosecutor's Office charged Miller with Murder II, ACA. Without this tip, the case would not have been solved. I sent a tip disposition on-line. However, I wanted to make sure you received the information.
