Scholarships have met with mixed results in Crime Stoppers.

Scholarships would be totally inappropriate in the event that the source of the funds were court generated which can only be spent for rewards or for administrative expenses. Likewise inappropriate if the source of the funds used for the scholarships was from charitable donors who thought their money was going to be used to pay Crime Stoppers rewards or the normal administrative costs of operating the program. Unless donors were told their money was not going to be used by a Crime Stoppers for rewards or normal expenses but for scholarships then this would be a flagrant violation of "donor intent"...a Cardinal Sin which has doomed many charities. Other problems are created by the scholarships due to jealousy and hurt feelings when not all candidates receive a scholarship. If the scholarship is awarded to the child of a Crime Stoppers board member or Crime a Stoppers law enforcement coordinator then there appears to be an ethics violation. If it benefits a director of the nonprofit corporation then the IRS can revoke the 501(c)(3) designation of Crime Stoppers. All in all, the problems far outweigh the benefits, and the public can become confused when a Crime a stoppers ventures out into activities that have absolutely nothing to do with solving crimes. Scholarships are nice but it is not what Crime Stoppers does.
