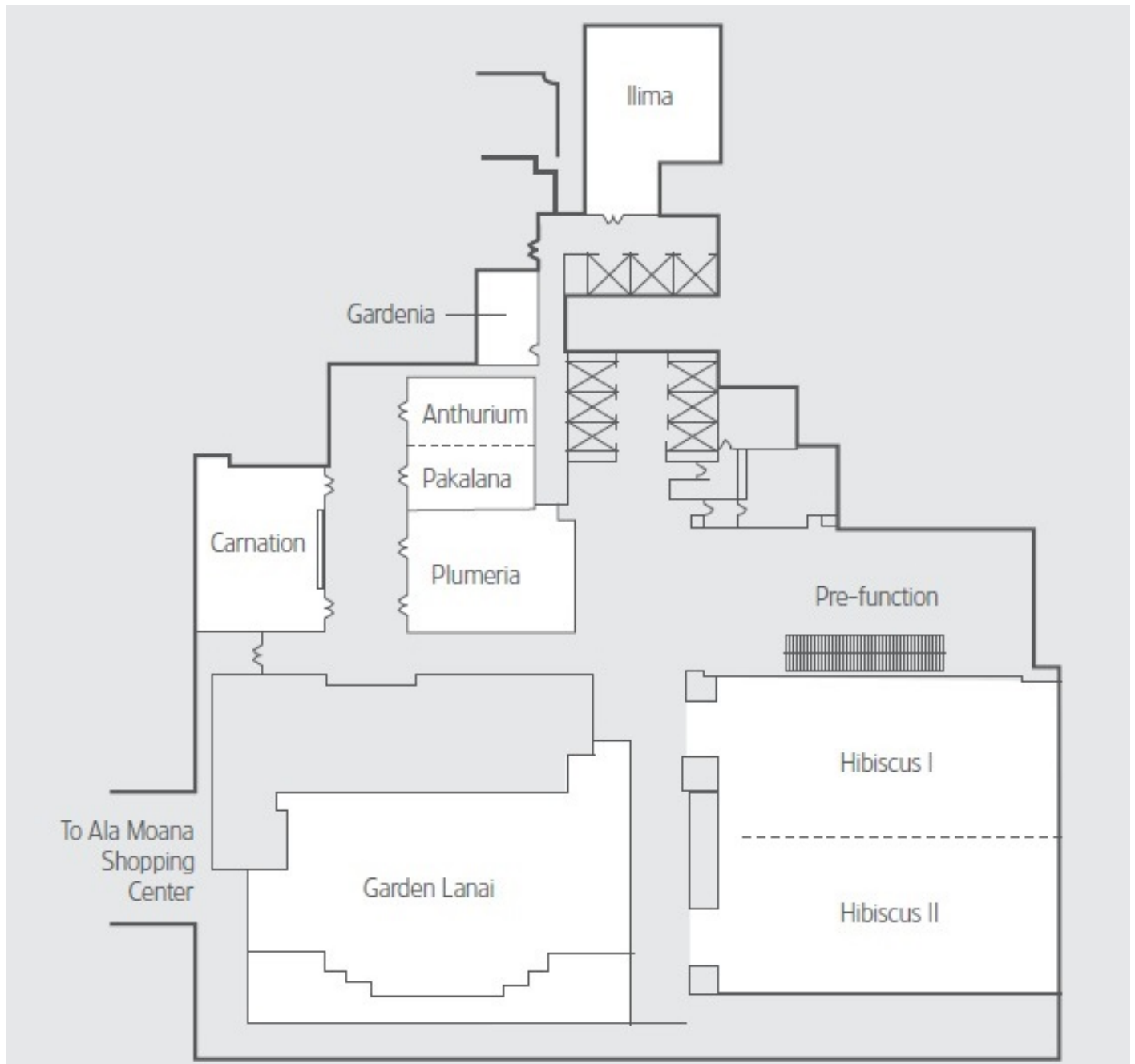

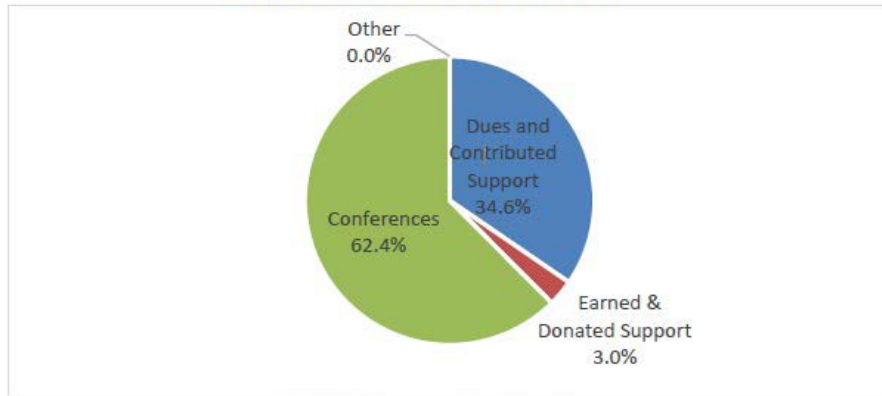

John W. Nelson



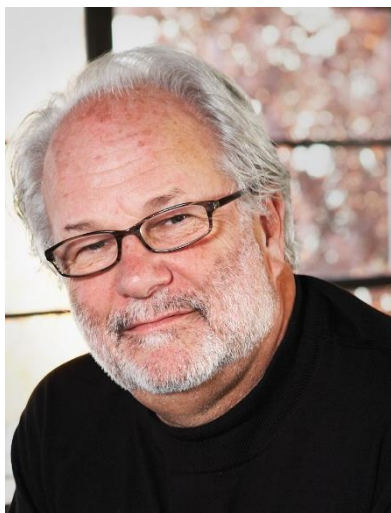

He was a criminal investigator for the majority of his career investigating homicides, sexual assaults, long term missing persons, and child abductions. Patrick has also served as the Training Coordinator for the CIA Unit. He has had the opportunity to create multiple courses in various subjects including Crime Assessment, Homicide Investigation, Equivocal Death Analysis, Cold Case Homicide Investigation, Child Death Investigation, Sexual Assault Investigation, Amber Alert/Child Abduction, and Missing and Endangered Persons Investigations. These courses have been taught to law enforcement agencies and related groups both nationally and internationally. He has continued to teach these courses into retirement, and continues to consult with law enforcement on investigations.
