

#### **ANONYMOUS REPORTING**

- Citizens can report crime "ANONYMOUSLY" and receive a CASH REWARD for an arrest and charge of a suspect
- Benefits
  - \*Identity of "Tipster" is unknown so will not have to testify in court
  - \*No fear of retribution
  - \*No fear of being labeled a "Racist"







### TRANSIT REGION

- Migration route from Turkey, as well as from the Middle East and Central Asia
- This route is also exploited by Traffickers and Terrorists
- Corruption is HIGH
- Once crossed into Croatia, all are free to roam ALL of Western Europe

## THE MEDIA

- Necessary to reach mass market to spread the word
  - \*Television (PSA's)
  - \*Radio
  - \*Social Media
  - \*Newspaper/Posters

- Police Media Relations is key in establishing positive working relationship w/Media
- Assists in producing Public Service Announcements (PSA's) to present to the Media outlets
- ► Advertising of the B1 APP is key

# THE PUBLIC

- To Report Criminal Activity ANONYMOUSLY using the B1 APP
- Public needs to be educated on the Initiative
- Public must feel secure in knowing they will remain ANONYMOUS and will never have to testify



# THE PUBLIC (cont.)

- Must be made aware there is a monetary gain to report Criminal Activity
- Must be made aware there could never be retribution as they will remain ANONYMOUS
- No fear of being labeled a "Racist"
- Must be made aware the procedure for collecting reward money
- ► REWARD MONEY WILL BE \$1000.00 US DOLLARS!!!

#### SAFEST SCENARIO

- Completely Anonymous
- Reward money is easily deposited by Crime Stoppers
- Convenient
- Western Union is WORLD WIDE
- No need to involve Western Union personnel as Tipster can p/u reward money with a PIN



Europe		
Up to 90 percent of the girls in rural areas don't go to school for fear of being abducted and sold into sexual servitude.		
A quarter of the women working in nightclubs claim they were forced into prostitution. The U.N. police task force is suspected of covering up its involvement in the sex trade.		
Up to 80 percent of the women trafficked as prostitutes in Western Europe may be Moldovans.		
Up to 400,000 Ukrainian women have been trafficked for sexual exploitation in the past decade, Ukraine says. Ukrainian sex slaves can fetch up to \$25,00 in Israel.		
Africa		
A girl can allegedly be bought as a slave in Abidjan for about \$7; a shipment of 10 children from Mali for work on the cocoa plantations costs about \$420.		
Light-skinned Arab Berbers today are thought to exploit hundreds of thousands of black African slaves. Slave raids in the 13th century began systemic slavery in Mauritania.		
Muslim tribesmen from northern Sudan still stage slave raids on non-Muslim Dinka peoples in the south, taking thousands of women and children.		
Asia		
An estimated 25,000 women and children are trafficked annually from Bangladesh.		
Parents have sold an estimated 15 million children into bonded labor in return for meager loans from moneylenders.		
The ruling military junta coerces minorities into forced labor in factories that benefit the regime and foreign corporations.		
A major source of women trafficked into Indian brothels; in addition, an estimated 75,000 people are trapped as bonded laborers in Nepal.		
Millions of Pakistanis, often members of religious minorities, are forced to work as brick makers or in the fields of feudal landowners.		
Children sold by their parents make up a significant percentage of prostitutes

## DRUG TRAFFICKING

#### **UNODC REPORTS**

- ► It's BIG Business
- Corruption is at the heart of the trade
- An estimated US \$28 Billion a year crosses the Balkans into the European Union
- Organized Crime has evolved, streamlining the process
- Cash-based economies make it easier to launder proceeds from Illicit Trade



### TRANSIT ROUTES OF AFGHAN HEROIN

#### The "Balkan Route"


- UNODC estimates between 50 & 60 metric tons of Afghan heroin transit via Serbia along Balkan smuggling routes
- Corruption is a major factor for smuggling success, especially in Kosovo and Bulgaria
- Croatia, Serbia & Bosnia are primarily transit countries

## Global drug trafficking

Main global drug supply routes



Russia has an estimated **2-2.5** million drug addicts, the majority aged **18-39**.

Russia consumes over 20% of heroin produced worldwide.

Afghan heroin accounts for 90% of the Russian narcotics market. The annual supply is estimated at 35 metric tons.

Some **30,000-40,000** Russians die annually of drug overdose. Another **70,000** die from drug-related causes

# ILLICIT TRADE

#### **CIGARETTE STATISTICS**

- 600 million cigarettes are illegally manufactured or smuggled worldwide per year...Equivalent of 1 pack in 10
- ▶ 1 in 3 cigarettes in BiH is illegal.
- ▶ 1 in 11 cigarettes in Western Europe are illegal
- Serbia has been the most aggressive in prosecuting smugglers, while Kosovo, Montenegro and Macedonia are the worst

# ILLEGAL ARMS DEALING (cont.)

- Serbia's Interior Ministry estimates between 200,000 and 900,000 small arms units in Serbia alone
- UN estimates approximately 750,000 small arms in Bosnia and roughly 450,000 weapons in Kosovo
- ► Finding that Smugglers are selling these weapons to people who can smuggle them in small quantities into the European Union

## REASONS SMUGGLING CONTINUES

- Inadequate resources available for Law Enforcement
- ► Political Corruption
  - \* BiH alone loses hundreds of millions of KM a year in lost Tax Revenue
- Lack of Political will to address the multifaceted problems

# TO MAKE THIS WORK WE NEED:

- **▶** Commitment to the Initiative
- Assistance with informing Police Agencies as well as the Public re: the B1 APP and encouraging them to help
- ► The ability to work with the Media in respective countries to promote the concept and the B1 APP
- ► The ability to follow-up on ANONYMOUS Tips that Crime Stoppers receives from the public

## INITIATIVE FUNDING

- ▶ For the first year to 18 months, Crime Stoppers will fund the Initiative.
- Imperative that the Initiative can produce Statistics in this time frame and relay to Private Sector Business as a means to secure Grant money
  - \*Phillip Morris Cigarette Company is following this Initiative very closely and Crime Stoppers will be submitting a US \$3 million Grant once statistics are available
  - \*Will also be engaging other International Business entities such as Facebook, Nike, Amazon, and Microsoft who utilize overseas workers where the potential for Trafficked Victims are high
- Once meetings are scheduled with these companies, may be asking some "Trusted Partners" to attend
- Benefits to respective Police Agencies have the potential for extra funding in ways such as equipment, more manpower, training and assistance with funding
- THERE WILL BE NO "OUT OF POCKET" EXPENSES FOR BALKAN POLICE AGENCIES

## **NEXT STEPS**

- Need mutual cooperation from all involved countries
- Crime Stoppers needs to have "Decision Maker" authorization to forward jurisdiction appropriate Tips
- ► ANONYMOUS Tips will be routed to country specific "Trusted Partners"
- All involved countries need to work with local Media to promote the B-1 APP and instill the ANONYMOUS TIP concept
- Encourage citizens to report crime via the B-1 APP, especially if they fear retribution

# NEXT STEPS (cont.)

- When an arrest has been made, notify Crime Stoppers for follow-up in order for us to pay the ANONYMOUS Tipster \$1000 US
- ► Keep statistics on arrests:
  - \* Type of crime
  - \* Names of arrested individuals
  - \* Location and details of arrest
- May need some "Trusted Partners" to accompany Crime Stoppers to emphasize the need for this Initiative to potential Business for Grant opportunities

# THE INITIATIVE IS WORKING

- Met with US Congressman Dave Reichert
- Goal is to make this a worldwide initiative
- Notified US State Department for "buy in" and funding
- Submitting Grants to international business for funding
