Corporate v. Public Records

- Definitions vary from State to State, so **KNOW YOUR LOCAL LAWS**
- Handling of records is determined by statute; both Federal and State.

General Guidelines

- Gender neutral
- Avoid familial references
- **REDACT**
- No tips via Social Media/Email



Example of “Tipster Tell All”

- “Jane Doe , **She’s My Mother** And She’s Always Coming Home High And On Drugs i Know This Because She Leaves The Drugs And Pills Sitting Around The House , Which Is Not Good At All Because Her 6 Year Old Son Could Get Ahold Of That And Get Sick. She’s Always Gone **And Never Here To Help Out My Dad** , She’s Alway Out Spending Food Money On Marijuana Or Other Drugs. I Don’t Know Where She Gets It From But She Does Have Messages In Or On Her Phone About Buying It. She’s Always Putting Drugs Before Her Own Family . **I Know This Because I Live With Her** And Witness It Every Day. She Smokes On Her Way To Her Weekend Jail And Anywhere Pretty Much.”

Sanitizing the Tip

What is Funneling?

- The practice by Law Enforcement of referring informants whose identities are known to Crime Stoppers Programs after having contact with Law Enforcement
- Rules should define and prohibit the practice
