INDIVIDUAL AWARDS

▶ Board Member of the Year

- ► This award is in recognition for selfless devotion, persistent service and significant contributions to a member Crime Stoppers program.
- ▶ Submissions are encouraged for civilians who are currently serving on the Board of Directors of a local or state Crime Stoppers program.

Coordinator of the Year

- ▶ This award is in recognition for outstanding performance and commitment, personifying a spirit of community cooperation demonstrating qualities of leadership.
- Nominees for this award may be either law-enforcement or civilian coordinators, although these individuals may not be voting members of the Crime Stoppers program.
- ▶ The nominees must have been an active in the program between / / January 1, 2022 and December 31, 2022 of a member program being in good standing with Crime Stoppers USA.
- ► If an individual has been a recipient of these awards within the last 5 years, ineligible to participate.

MEDIA AWARDS

- ▶ Print Public Service Announcement
- ▶ Radio Public Service Announcement
- ► Television Public Service Announcement
- Social Media (Facebook, Twitter/X, Instagram, etc.)
- ► Awards are divided into population categories:
 - \triangleright 0 100,000
 - **▶** 100,001 250,000
 - ▶ 250,001 1 million
 - ▶ 1 million +
- ► If an organization was an award recipient in a specific media category last year, it is ineligible in that same category for this award year

COMMUNITY INITIATIVE AWARDS

- Special Initiative award projects
 - ► This award is in recognition for the inventive and original development of an exceptional event or project to benefit Crime Stoppers in the community in which it serves.
 - ▶ The project and/or event must have taken place or implemented during the period of January 1, 2022 to December 31, 2022.
- ▶ Awards are divided into population categories:
 - **▶** 0 − 100,000
 - **▶** 100,001 − 250,000
 - ► 250,001 1 million
 - ▶ 1 million +
- ► If an organization was an award recipient in this category last year, it is ineligible for this award year

HOW DO I FILL OUT ALL THESE FORMS?

GET 'ER DONE!

- Open up the saved pdf awards submission form from your file folders
- ► Complete the nomination submission form for the specific award and save the file once filled in
 - It is a fillable form pdf document
- Collect and place collateral documents, images, audio files and video files into awards file folder
 - Written documents must be in .pdf,
 - ▶ Photos or pictures in .JPEG, .JPG, .PNG or .GIF format
 - Written documents requested in the nomination process be converted to Adobe Acrobat PDF files
 - Videos submitted in either .MPEG-4 or .MOV format
 - No URL's from wesbtire allowed. Please obtain a video in the above referenced format
 - Audio files be submitted in either .MP3 or .WAV format







HOW DO I GET MY SUBMISSION TO THE CSUSA AWARDS COMMITTEE?

- ▶ Go to the General Guidelines page and click on '2023 Award Submission' in Awards Submission Process section 4.

- ▶ This will bring you to the 2023 CSUSA Award Submission Forms site
- ▶ Fill out this form with email address and program name
- Finally, click on 'Add File'
 - ▶ This is where you will upload your submission files saved previously.

 - ▶ Then click 'Submit'
