





- Motion detection setting for dealerships

- Simple installation, no wiring (self-powered), high powered magnets or 3M adhesive
- Does not affect manufacturer's warranty (no OBD plugin or hard wiring)





Dealers view inventory location on the Locate IC web platform and mobile app.








Lot Protection – Geo Fence





If a vehicle is stolen from a Dealership's lot, KYCS will send a notification to the dealer. Then, through its platform, KYCS will commence the recovery process.

Device Features – Virtual Fencing



- Exclusively with KYCS Locate devices through KYCS Global Inc.
- All 180 seaports in North America are equipped with Virtual fences
- If a vehicle crosses the virtual fence at one of the seaports, the Locate device will send a notification to the Recovery team upon its next scheduled check in



Device Features – Range Finder



 Locate is the only device on the market today that continues to function from inside a shipping container.

 Locate's Range Finder feature is available to authorities only, which helps pinpoint the precise container of the stolen vehicle. This allows authorities to obtain warrants to recover the stolen vehicle.



Device Features – Recovery Mode





If a consumer's vehicle is stolen

- KYCS Locate is switched into Recovery Mode during its next scheduled Health Check
- The Recovery team will send a Recovery
 Mode command to the unit so that when
 the Locate wakes up at its scheduled check
 in time they will now take control and be
 able to communicate with the LOCATE in
 real-time





Recovery Mode tracks the location of the stolen vehicle as frequently as necessary to provide Law Enforcement with the evidence they need to secure warrants



How Factory Installed GPS Tracking Devices Are Disabled





- Great solution for telematics, fleet management, data collection – not designed for recovery
- OEM tracking systems repeatedly emit signals making them highly susceptible to prompt detection and removal by thieves
