Elections will be held this year for all Crime Stoppers USA Officers, At Large Board Members and Regional Directors in Odd Number Regions, elected for (2 years). All elected positions will take office at the Crime Stoppers USA Post Board Meeting, in Denver, CO, November 6, 2023. If there are Positions still open after the election, new applications will be presented to the CSUSA Nominations Chair for presentation and approval of the CSUSA board. Applications will be accepted pending background approval.
