- 3. Sponsoring Associates Any person or corporation who provides financial support to Crime Stoppers USA, Inc., and/or actively participates in the organization as determined by the Board of Directors
- 4. Alumni Any past member of a Board of Directors, law enforcement/program coordinator or media participant from a program that was a member in good standing with Crime Stoppers USA, Inc. Alumni membership is personal and cannot be transferred.

#### **Proposed B.** Non-Voting Associates

- 1. Law Enforcement Associate Programs A local Crime Stoppers program that holds itself out as a Crime Stoppers entity but does not meet all requirements of a Crime Stoppers USA member in good standing.
- 2. Non-USA Crime Stoppers Programs Any Crime Stoppers program that is domiciled outside of the United States, or United State territories or possessions.
- 3. Sponsoring Associates Any person or corporation who provides financial support to Crime Stoppers USA, Inc., and/or actively participates in the organization as determined by the Board of Directors
- 4. Alumni Any past member of a Board of Directors, law enforcement/program coordinator or media participant from a program that was a member in good standing with Crime Stoppers USA, Inc. Alumni membership is personal and cannot be transferred.
- 5. Life Members Any individual that has served on the Crime Stoppers USA, Inc. Board of Directors, has been voted on by the Board of Directors, and been given the distinction due to long-term support and engagement, and commitment to the mission.



6. Honorary Members – Any individual that Crime Stoppers USA, Inc. may wish to honor nationally that actively participates in the advancement of the organization as determined by the Board of Directors. (Moved from Article VI, Section 8 and changed from Director to Member)

#### **Article VII Officers**

#### Section 2

#### Current

Term of Office – The Board Chair, Vice Chair, Secretary and Treasurer shall serve for two years or until their successors are elected. To provide for a reasonable rotation, the Board Chair and Vice Chair shall not serve more than **two consecutive terms** in the position they were elected to hold. The Secretary and Treasurer may serve up to **four consecutive terms in office**.

#### **Proposed**

Term of Office – The Board Chair, Vice Chair, Secretary and Treasurer shall serve for two years or until their successors are elected. To provide for a reasonable rotation, the Board Chair and Vice Chair shall not serve more than two terms which may or may not be served consecutively in the position they were elected to hold. The Secretary and Treasurer may serve up to four terms in office, which may or may not be served consecutively.

#### Section 4. Eligibility of Officers

#### Current

**A.** Board Chair – To be eligible for nomination as Board Chair an individual must have served on the Crime Stoppers USA, Inc. Board of Directors for **the immediate two years** prior to running for this position and be endorsed by a member in good standing.

#### **Proposed**

**A.** Board Chair – To be eligible for nomination as Board Chair an individual must have served on the Crime Stoppers USA, Inc. Board of Directors for **two of the immediate past five years** prior to running for this position and be endorsed by a member in good standing.

#### Current

**B.** Vice Chair/Secretary/Treasurer – To be eligible for nomination as Vice Chair, Secretary or Treasurer, an individual must have served on the Crime Stoppers USA, Inc. Board of Directors **the immediate past year** prior to running for this office and be endorsed by a member program in good standing.

#### **Proposed**

**B.** Vice Chair/Secretary/Treasurer – To be eligible for nomination as Vice Chair, Secretary or Treasurer, an individual must have served on the Crime Stoppers USA, Inc. Board of Directors **one of the immediate past five years** prior to running for this office and be endorsed by a member program in good standing.



#### Article X Finance

#### Section 5.

#### Current

The Board Chair, Vice Chair, Secretary and Treasurer shall have their signatures on file at the Corporation's depository. Any check, payment, or expenditure \$3,000 or under shall require one signature. Any check, payment, expenditure of the corporation over \$3,000 shall be authorized in writing by any two members of the elected Executive Committee, (Board Chair, Vice Chair, Secretary or Treasurer).

#### **Proposed**

The Board Chair, Vice Chair, Secretary and Treasurer shall have their signatures on file at the Corporation's depository. Any check, payment, or expenditure \$3,000 or under shall require one signature. Any check, payment, expenditure of the corporation over \$3,000, excluding previously approved contracts and reoccurring payments, shall be authorized in writing by any two members of the elected Executive Committee, (Board Chair, Vice Chair, Secretary or Treasurer, and be presented to the Board of Directors at the next scheduled Directors meeting and duly recorded in the minutes of said meeting.

As part of that position, Jared was a public representative on local media for publicizing Crime Stoppers cases. He has worked as one of LPD's on-call Crime Scene Investigators for 15 years and is an IAI certified CSI. 14 years ago, he began a career as LPD's Audio Video Technician and received a Law Enforcement Video Association's certification as a Forensic Video Technician in 2013. In this capacity, Jared has worked on several high-profile homicide cases, testifies regularly in court and has assisted several outside Police and Fire departments with their forensic video evidence needs.

As part of Jared's duties, he created and managed LPD's Crime Stoppers website. LPD releases Crime video/images for every case that is unsolved and needs public assistance in identifying the suspects captured in video, from a stolen sock up to a Homicide. The website averages at least 800 cases posted every year and on average 35-40% of those cases are cleared! A huge success for cases that were not going to be solved without that Crime Stoppers tip.

Since a large portion of the cases being posted to Crime Stoppers were of local thefts, Jared joined and then became the Director of the Local Retail Coalition for the last 10 years, working with Loss Prevention members in the city and later expanding the reach to include the entire Southeast area of Nebraska. The workload Jared performed was also hand in hand with the Lincoln/Lancaster County Crime Stoppers

mission. Jared joined the local board in 2009 to assist the board with advice from his perspective in the department. He served as Vice President and an interim Law Enforcement coordinator but now holds a law enforcement advisory position on the board. Jared has received numerous departmental commendations for his video work, for the success of the Crime Stoppers page and was named LPD's Civilian of the Year in 2011 and 2019. Jared joined CSUSA in 2020 as the Region #9 Director after attending two of the National Conferences. Jared is excited to help other programs and to be a part of something that simply started as a part of his job duties but evolved into a passion because of the success stories he has seen.
